The supporting clause may set out the temporal milieu for the focal clause or specify a condition or presupposition for it or a preliminary statement of it, as in Although John has been studying German for years (the supporting clause), he does not speak it well (the focal clause). Professor Dixon's extensive opening discussion is followed by fourteen case studies of languages ranging from Korean and Kham to Iquito and Ojibwe. The book's concluding synthesis is provided by Professor Aikhenvald.

It provides impressive evidence of the concern that workers in environmental psychology and environmental design are displaying for the child as a user of the designed environment and indicates a recognition of the need to apply theory and findings from developmental and environmental psychology to the design of environments for children. This seems to me to mark a shift in focus and concern from the earlier days of the interaction between environmental designers and psychologists that occurred some two decades ago and provided the impetus for the establishment of environmental psychology as a subdiscipline. Whether because children—though they are consumers of designed environments are not the architect's clients or because it seemed easier to work with adults who could be asked to make ratings of environmental spaces and comment on them at length, a focus on the child in interaction with environments was comparatively slow in developing in the field of environment and behavior. As the chapters of the present volume indicate, that situation is no longer true today, and this is a change that all concerned with the well-being and optimal functioning of children will welcome.
